

# 2025 PIT Quick Guidance

## Point-in-Time Count

### **Clarity HMIS projects:**

CCFL System Administrators will pull PIT data for projects participating in the Clarity HMIS. **Only clients who are literally homeless according to HUD's definition will be pulled into the PIT report.**

We need your support to make sure that your project has the most **current information on the Client Profile tab and Client Enrollment screen.**

To be pulled as enrolled **all housing projects must make sure clients have an entry into your housing projects prior to January 21st 2025.** **Do not exit clients on the day of the PIT count.** If clients need to be exited, **the exit must be on or after January 22nd, 2025.**

### **All NON-Clarity HMIS System users that supply housing for the homeless, including Churches and DV providers:**

**All Street Outreach coming into contact with individuals living in a place not meant for habitation on the night of January 21st, 2025th during the dusk to dawn hours must collect:** Clarity ID (if available), Full name (first and last), DOB, Gender, and Race and Ethnicity. Street Outreach staff will collect the required information in the *2025 Street Outreach PIT Unsheltered Form* provided. This will be collected for clients and their household members with a primary nighttime residence that is a public or private place not designed for or ordinarily used as a regular sleeping accommodation for human beings, such as a car, park and abandoned building.
